## Objectives:

The Programme for which this Memorandum of Understanding is signed is to be known as "Promotion of Academic and Research Initiatives" of Government College of Education, Canal Road, Jammu and State Council of Educational Research & Training J&K, Divisional Office Jammu. The main objectives of the MOU are:

- To promote collaboration between Government College of Education and SCERT,
   Jammu in organizing Teacher Training Programmes wherever feasible.
- 2. To encourage faculty members of both institutions to jointly formulate projects, undertake research work, have access to research hub and provide mutual academic support with due approval of the concerned authorities.
- To strengthen institutional cooperation through capacity development programmes, faculty exchange as resource persons, and sharing of infrastructure within identified areas of collaboration.

## **Faculty Exchange Programmes:**

1. The faculty/ staff will be encouraged to deliver Lectures/ Talks as resource persons.

- 2. One or two faculty members can become part of the editorial board in Magazine/ Journals of the institutions.
- The faculty members of both the institutions shall be encouraged to send articles to college magazine/ SCERT magazine.
- 4. The faculty members can also work in Research projects after due consultation with the respective Heads of both the institutions.
- All faculty exchange Programmes shall be performed with the prior approval of the competent Authority.

# Joint Conferences/ Workshops/ Seminars:

Both, Government College of Education, Canal Road, Jammu and State Council of Educational Research and Training J&K, Divisional Office Jammu agree to conduct joint conferences, workshops, seminars, training courses whenever feasible, within the areas of cooperation.

# **Sharing of Facilities:**

- 1. Both Institutions agree to:
- a) Exchange materials developed in-house with the prior approval of the competent authority.
- b) Share resources, content, and pedagogical material developed for ITEP and other training programs for Pre-service and In-service Teacher Trainings.
- c) Facilitate joint access and use of toy-based learning resources, tool kits, and training modules for strengthening foundational, preparatory and other stages of education.
- d) Enhance the standards of Teacher Education programmes by mutual sharing of knowledge resources such as libraries, e-content, and capacity-development materials.
- e) Utilize the facilities/resources of research hub established at Govt. College of Education, Canal Road, Jammu.

## Areas of cooperation:

- The areas of cooperation will be defined from time to time by the coordination committee setup for the purpose for Pre-service and In-service Teacher Training programs and educational researches.
- Principal, Government College of Education, Canal Road Jammu shall act as coordinator from Government College of Education, Canal Road, Jammu & Joint Director, SCERT J&K, Divisional Office Jammu shall act as coordinator from SCERT J&K, Jammu.

### **Coordination Committee:**

A Coordination committee will be constituted for mutual consensus.

## Validity & Period of Memorandum of Understanding:

The MOU, purely academic with no financial implications shall be effective from the date of signing by both the parties and shall remain in operation initially for 2 years or until either party serves notice on the other of its intention to terminate it, in which event, the MOU shall stand terminated at the end of one calendar month from the date of issue of such a notice.
